# **Government Supports for International Students**

### **New South Wales**

### \$20m International Student Support Package \*\*MAY ANNOUNCEMENT\*\*

A new 24/7 international student support service available through the NSW Government COVID-19 hotline offering free advice and information about other measures, including the moratorium on rental evictions and medical, mental health, legal and emergency support.

The package includes a temporary housing scheme, targeted at students in genuine need and delivered through approved student accommodation or homestay providers, as well as 50,000 free subscriptions to the multilingual My Legal Mate student app.

Limited details were made available at time of announcement – students can call 13 77 88 to access these supports

#### Mental Health Support

Additional funding has been provided to the NSW Mental Health Line (1800 011 511) and Lifeline (13 11 14) which are available to NSW international students.

#### COVID-19 Health Costs Waiver

NSW Health will waive costs for people not eligible for Medicare and whose health or travel insurance does not cover COVID-19 treatment, and waive payment and debt recovery procedures for ambulance transfers of people taken to NSW Health facilities for people suspected to have a COVID-19 infection or who are taken for assessment. <u>Read more</u>

#### International Student Legal Services

International Students can receive free legal advice through the Study NSW funded <u>International</u> <u>Student Legal Service</u>.

#### **Accommodation Protections**

The NSW Government is introducing a support package that includes an interim 60-day stop on landlords seeking to evict tenants due to rental arrears:

- for tenants who are financially disadvantaged by COVID-19
- where landlords and tenants try to negotiate rental reductions in good-faith, and
- it would not be fair and reasonable in the circumstances to terminate the tenancy

The package immediately:

• applies a 60 day stop on new termination notices and termination applications to the NSW Civil and Administrative Tribunal where these are terminations due to rental arrears due to COVID19

## Victoria

#### International Student Emergency Relief Fund

International students can apply for a contribution from the Victorian Government, who have <u>undertaken to make co-contributions</u> of up to \$1,100 to hardship payments made by Victorian universities, TAFEs, private Vocational Education and Training Providers and English Language Colleges. Detail of the payment-matching mechanism and student eligibility criteria were unavailable at time of publication, but <u>students are able to lodge an expression of interest in the scheme</u>.

#### Accommodation Supports

#### **Rent Relief Grant**

International students can apply for rent relief grants of up to \$2000 if they are experiencing financial hardship as a result of the coronavirus (COVID-19) crisis. <u>Details are available here.</u>

#### Free Legal Advice for International Students on Housing

The Study Melbourne International Student Housing and Accommodation Legal Service provides free legal advice to international on accommodation matters. Students can email <u>info@studymelbourne.vic.gov.au</u> to make an appointment.

#### **Tenancy Eviction Protections**

Students suffering financial hardship due to coronavirus (COVID-19) are protected from eviction for rental arrears for six months from 29 March 2020. Information for tenants is available here.

#### Working for Victoria Program

International students are able to apply to the <u>Working for Victoria</u> initiative which helps Victorians, including people who have lost their jobs due to the economic impacts of coronavirus (COVID-19), find new work opportunities.

#### COVID-19 health costs waiver

Victorian hospitals will waive the costs of treatment for overseas travellers, including international students, with symptoms of coronavirus who fall ill in Australia and do not have adequate insurance coverage. <u>Read more here</u>

#### Mental Health Supports

Counselling and other supports are available to international students through Study Melbourne's <u>'Study Well' initiative</u> –students can also access these supports on 1800 056 449 or via <u>email.</u>

#### Community Supports for International Students

Study Melbourne is maintaining a community supports resource hub with detailed information on where to find <u>support in the community</u> across Melbourne.



### Queensland

#### \$2.2 Million in support for International Education including Online Student Hub

International students are able to access accommodation, travel and employment advice, mental health and wellbeing supports, and assistance with academic complaints and legal referrals through Queensland's Student Hubs, which have transitioned to an online business model. Students can access the Online Student Hub services <u>here</u> or on 1800 778 389.

#### Jobs Finder Queensland

International students who have been impacted by coronavirus (COVID-19) and looking for work, can <u>register to be matched with job opportunities</u> by local professional recruitment agencies through Queensland's Job Finder program. There Is also access to free online training. This program Is eligible to those who have lived in Queensland for six months or longer and hold a Visa that allows you to work.

### South Australia

#### International Student Support Package

The South Australian Government is providing some emergency relief for international students studying with independent providers:

A \$500 emergency cash grant will be available to international students not studying at one of the public universities, currently enrolled in a course, living in Adelaide and who meet the criteria.

A one-off \$200 assistance payment per student living with South Australian families provided to Homestay families.

Students are able to register for an update when applications are opened.

A fund has also been made available to UniSA, Adelaide University and Flinders University for distribution to their international students.

#### Mental Health Support

StudyAdelaide have collated available mental health and wellbeing resources for students online.



### Tasmania

#### Pandemic Isolation Assistance Grants

A one-off payment for low-income individuals who are required to self-isolate by Public Health. Adults can receive a grant of \$250, and households can also receive \$125 per dependent child. Grants are capped at \$1000 per household. <u>More information is available here.</u>

#### Study Tasmania Supports and Resources

Study Tasmania has collated a portal of Tasmanian Non-Government Organisations and community organisations that have been provided with additional funding to support international students needing emergency relief and assistance. Students can <u>access the portal here.</u>

#### **Tenancy Eviction Protections and Rent Freeze**

Any notice to vacate issued by an owner to a tenant is of no effect until 30 June 2020 (exceptions apply). Any rent increase that was due to take place between 23 April 2020 and 30 June 2020 will no longer occur. This includes any rent increase where notice was given prior to 23 April 2020, if that rent increase is yet to take place. This measure will be reviewed prior to 30 June 2020 and may be extended. Other assistance can also be provided for rental adjustment negotiations and other leasing issues. Read the details here

#### **Travel Advice and Repatriation Assistance**

The Tasmanian Government will assist students seeking to return to their home country with travel advice, and if necessary due to genuine financial hardship we will on a case by case basis assist with financial support to do so. The full details of this program are yet to be released, but students can register their interest in support to return to their country of origin via the Tasmanian public health hotline (1800 671 738 ) by 23 May 2020.

### Western Australia

#### StudyPerth Crisis Relief Package

The StudyPerth Crisis Relief program is available to international students in Western Australia who are in immediate, emergency need of food or accommodation. Organisations and associations who are able to support international students with food, shelter, rights and health and wellbeing may also eligible for support. Applications are required. <u>Students can apply online for the program here.</u>

#### **COVID-19 Information for Students**

StudyPerth have collated health and wellbeing supports as well as accommodation and financial supports into their COVID-19 Student portal, <u>available here</u>. Students can enquire about available supports <u>online</u> or email <u>reachout@studyperth.com.au</u>

#### **COVID-19 Health Costs Waiver**

The WA Minister for Health has confirmed that those people who are not eligible for Medicare AND who present to WA Health facilities for assessment in relation to COVID-19 infection, will not be charged out of pocket expenses. <u>A WA Health factsheet is available here</u>

#### **Cost of Living Relief**

A freeze will be placed on household fees and charges, including electricity, water, motor vehicle charges, the emergency services levy and public transport fares for WA residents. <u>More information is available here.</u>



### Western Australia (cont.)

#### **Rent Relief Grant**

International students in WA who are experiencing financial hardship as a result of COVID-19 can apply for rent relief grants of four weeks rent (up to a maximum \$2000). The Grant is paid directly to landlords.

Students meet the WA Rent Relief eligibility criteria where they:

- Resident in WA
- Have, or shortly will have, lodged a tenancy bond with the Bond Administrator
- Live in a private residential property, rooming house or residential park
- Have agreed to a reduction in rent with the landlord, or have engaged in <u>Consumer</u> <u>Protection's dispute resolution service</u>
- Are in 'financial hardship', meaning:
  - Lost work on or after 20 March 2020
  - Have applied for Centrelink income support
  - Have less than \$10k of household savings
  - Are currently paying rent of at least 25 per cent of the total household income after tax

It's anticipated the online form for applications will be available from Friday May 1, 2020.

#### **Tenancy Eviction Protections**

International students are protected by a six-month moratorium on residential tenancy evictions for rental arrears. <u>Details are available here</u>

## Australian Capital Territory

#### Jobs for Canberrans Fund

ACT residents can apply for temporary employment (until June 2021) with the ACT Government through the Jobs for Canberrans Fund. International students will benefit from the priority attention the Fund provides to applicants who are ineligible for Federal Government supports.

The ACT Government is recruiting for cleaning, administration, customer service, fire recovery restoration, and garden or building maintenance roles. Interested students can apply here.

#### **Residential Tenancy Support**

#### Rent Relief

The government will provide a land tax and rates rebate to landlords of residential properties who reduce rents by at least 25 per cent for tenants impacted by COVID-19.

The rebate will be equal to 50 per cent of the rent reduction, capped at \$1,300 per quarter (around \$100 per week), for up to six months. This will provide rental relief to impacted tenants of up to \$200 per week.

#### **Eviction Moratorium**

The ACT Government is also preparing regulations to support any tenant under financial duress due to COVID-19 including a short-term moratorium on evictions, temporary freeze of rental increases and prevention of 'blacklisting' as a result of being unable to pay rent.

# Australian Capital Territory (cont.)

#### ACT Government Support package Hardship funds

International students affected by COVID-19 will be able to access support through a \$150,000 ACT Government support package provided to the Red Cross, accessed by affected students through their higher education provider. Details of this program have not yet been released. Read more

## **Northern Territory**

#### International Students Support – Red Cross Hotline

Red Cross have partnered with Melaleuca Refugee Centre to provide emergency relief for international students and visa holders and Territorians who have lost their job or their income has been reduced because of coronavirus (COVID-19).

Students can contact Red Cross on 0403 987 018 to access emergency relief and support.

#### Worker and Wellbeing Fund

The Worker and Wellbeing Fund can support international students who have lost work or had their hours reduced due to COVID-19, and who are not already receiving financial and/or wellbeing support including Centrelink benefits.

The Worker and Wellbeing Fund will:

- help people access wellbeing and other counselling or support services that are available
- help people navigate the welfare system and access income and any other financial support available
- help workers who have lost their job find new employment opportunities fast -such as guiding people to job matching services like the Territory Jobs Hub
- assist Territorians who require access to accommodation and other essentials.

Students can connect with the NT Government through the Fund portal or via email.

#### **Territory Jobs Hub**

The NT Government has created a free <u>Territory Jobs Hub</u> to connect NT residents with employment opportunities if they have lost their job due to COVID-19.

## Federal

#### Access to Superannuation

International Students experiencing financial hardship who have been living in Australia for longer than 12 months can apply to <u>access their Australian superannuation</u>.

#### Exemptions for the 40 hour per fortnight work limit:

Student visa holders working at health and NDIS providers, as well as at supermarkets are being exempted from their usual work limitations of 40 hour per fortnight. The exemption for supermarket workers ceases on 1 May 2020.

Student visa holders already enrolled in nursing can undertake work to help and support the health effort against COVID-19 as directed by health officials. On 23 April 2020, this was expanded to include all student visa holders enrolled in health care related courses supporting the health effort against COVID-19 as directed by health officials. Enforcement action will not be taken regarding health care students working in these circumstances.
